C. ATHLETE ELIGIBILITY

C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).





Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of FIBA, may participate in the Olympic Games Paris 2024.

C.2. Age requirements

To be eligible to participate in the Olympic Games Paris 2024, athletes must be born before 1 January 2006.

C.3. Additional IF eligibility criteria

To be eligible to participate in the Olympic Games, all athletes must have a confirmed account at <u>play.fiba3x3.com</u> and at least two (2) athletes, out of the four (4) per team, have to be ranked within the top 10 of their national individual ranking (only athletes with verified eligibility are considered) on 24 June 2024 (i.e. two weeks before the Paris 2024 Sport Entries deadline on 8 July 2024); whilst the other two (2) athletes of the team, have to be <u>either</u> ranked within the top 10 of their national individual ranking (only athletes with verified eligibility are considered) on 24 June 2024 <u>or</u> have participated in minimum one (1) FIBA 3x3 Official Competition between 1 January 2023 and 24 June 2024.

Notwithstanding the above, to be eligible to participate in the Olympic Games, the athletes must comply with the specific nationality criteria for 3x3, as set out in the FIBA Internal Regulations, which are summarised below:

- They must hold legal nationality of the represented country;
- They must have presented a passport of the represented country issued by competent authorities before 1st of January of 2022;
- They cannot have played for the national team in basketball (5v5 or 3x3) for another country in an Official Competition of FIBA, except with a special dispensation from FIBA's Secretary General.

Only NOCs with National Associations which comply with the following criteria are eligible to participate in the Olympic Games:

- Have at least one staff member with a valid FIBA 3x3 e-learning certification by 1 November 2023;
- Have not been the object of a suspension or otherwise sanctioned by FIBA.

D.2. HOST COUNTRY PLACES

If the NOC of the host country of the Olympic Games Paris 2024 has no team directly qualified for the Olympic Games Paris 2024 as per the Ranking List, FIBA will assign such NOC one (1) quota place to their highest ranked team (Men or Women) in the corresponding Ranking List (with preference to the women's team in case of tie).

E. CONFIRMATION PROCESS FOR QUOTA PLACES

E.1. CONFIRMATION OF QUOTA PLACES

FIBA will publish on its <u>website</u>, the results of each of the qualification events within one (1) day after the conclusion of the event.

FIBA will confirm in writing to the NOCs, within 15 days after the last day of each qualification deadline or within 5 days after the last day of each qualification event, the quota places they have been allocated. The NOCs will then have to respond within 10 days of each event, or 30 days after the ranking cut-off date, to confirm to FIBA if they wish to accept these quota places, as detailed in section **G. Qualification Timeline**.

E.2. CONFIRMATION OF HOST COUNTRY PLACES

The NOC of the host country must confirm in writing to FIBA by 1 September 2022 the interest to use its host country place.

F. REALLOCATION OF UNUSED QUOTA PLACES

F.1. REALLOCATION OF UNUSED QUOTA PLACES

If an allocated quota place for the Olympic Games Paris 2024 is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC or for any other reason the NOC is unable to use it, the quota place will be reallocated to the next highest ranked and eligible NOC, not yet qualified, at the event or under the methodology by which the quota place was originally obtained, respecting the maximum quota per gender and per NOC.

F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused host country place will be reallocated to the next highest ranked eligible team in the Ranking List, not yet qualified for the Olympic Games Paris 2024, respecting the maximum quota per gender.

D.2. HOST COUNTRY PLACES

The FIBA Central Board has decided to grant the automatic qualification place to the Men's and Women's teams of the host country.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

E.1. CONFIRMATION OF QUOTA PLACES

FIBA will publish the final results after each qualification event on the official <u>website</u> and inform the qualified NOCs/NFs accordingly.

The NOCs will then have two (2) weeks to confirm if they wish to use these quota places, as detailed in paragraph G. Qualification Timeline.

For the FIBA Olympic Qualifying Tournaments, the NOC/NF must confirm their participation to the Olympic Games to FIBA should they qualify at the same time as registering their team(s) for the FIBA Olympic Qualifying Tournaments, namely **by 30 November 2023.**

F. REALLOCATION OF UNUSED QUOTA PLACES

F.1. REALLOCATION OF UNUSED QUOTA PLACES

The following applies in case a quota place: i) is not confirmed by the respective NOC within the applicable deadline, or ii) is declined or iii) the NOC/NF is unable to use the quota place for any reason whatsoever:





If the quota place is allocated at the FBWC 2023 or at the FOPQTs, the quota place will be reallocated to the next highest-ranked NOC not yet qualified, from the respective event where the quota place was obtained, taking into consideration geographical criteria if applicable to such quota place.

If the quota place is allocated at the FIBA Women's Continental Cups or the FWOPQTs, the quota place will be reallocated to the next highest-ranked NOC not yet qualified, from the respective event where the quota place was obtained.

If the quota place is allocated at the FOQTs or FWOQTs, then the place will be reallocated to the next highest ranked team not yet qualified from the respective FOQT or FWOQT.

F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

In case the automatic qualification places are not granted to the host country by the FIBA Central Board, or in case the host country declines the automatic qualification places or is for any reason whatsoever unable to use them, FIBA will reallocate those place(s) to the next highest placed team(s) from the FBWC 2023 (the best classified among those teams not directly qualified for the Olympic Games) and FIBA Women's Olympic Qualifying Tournaments (11th team from the Tournaments). In case France accepts the host country place but is also granted a quota place as the best European team at the FBWC 2023, the quota place will be reallocated the next highest ranked team from Europe at the FBWC 2023.
