##### C. ATHLETE ELIGIBILITY

###### C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).



Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of IFSC, may participate in the Olympic Games Paris 2024.

### C.2. Age requirements

To be eligible to participate in the Olympic Games Paris 2024, athletes must be born before 1 January 2008.

### C.3. Additional IF eligibility criteria

Athletes must also comply with the following criteria:

- Hold a valid international license issued by the IFSC for the Olympic Games year
- Not have been banned from participating in any IFSC competition during the Olympic Games year.

## D.2. HOST COUNTRY PLACES

In the case where the host country does not qualify the athletes per gender through the qualification pathway outlined in section **D. Qualification Pathway**, the host country will be allocated one (1) quota place for each gender, on the condition that the athletes meet the eligibility criteria described under section **C. Athlete Eligibility** of this document.

In addition to this, the eligible athletes must have participated at least in one (1) of the events mentioned in section **D.1. Quota Places** of this document and must be ranked within the top 36 of the Series Ranking in the **D.1.3. Olympic Qualifier Series**.

## D.3. UNIVERSALITY PLACES

Two (2) Universality places, one (1) per gender, are made available to eligible NOCs at the Olympic Games Paris 2024.

On 1 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality places is contained in the “*Games of the XXXIII Olympiad, Paris 2024 - Olympic Games Universality Places - Allocation Procedure and Regulations*” document.

The selected athletes shall meet the required eligibility criteria defined under section **C. Athlete Eligibility** of this document. In addition to this, the athletes must qualify to **D.1.3. Olympic Qualifier Series** and be ranked within top 36 of the Series Ranking.



## E. CONFIRMATION PROCESS FOR QUOTA PLACES

### E.1. CONFIRMATION OF QUOTA PLACES

The IFSC will publish the results of the event within five (5) days after the last day of the event on [its website](#).

The IFSC will confirm in writing to the NOCs within five (5) days after the last day of each event, or ranking, the quota places they have obtained. The NOCs will then confirm to the IFSC if they wish to confirm or decline these quota places, as detailed in section **G. Qualification Timeline**.

If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, the quota place will be allocated to the next highest placed eligible athlete, not yet qualified, from the same event/ranking, respecting the maximum quota per gender per NOC.

### E.2. CONFIRMATION OF HOST COUNTRY PLACES

In case where the host country did not qualify any athletes through the events/rankings outlined in section D of this document, the IFSC will send a request in writing to the NOC as outlined in **G. Qualification Timeline**.

The IFSC will ask to the NOC if they wish to use the host country place for the eligible athlete(s), applicable per gender, as detailed under section **D.2. Host Country Places**, and the NOC will then confirm to the IFSC if they wish to use such quota place.

## F. REALLOCATION OF UNUSED QUOTA PLACES

### F.1. REALLOCATION OF UNUSED QUOTA PLACES

#### **For D.1.1. and D.1.3. Pathways**

Unused quota place(s) will be reallocated to the next highest placed eligible athlete, not yet qualified, at the respective event where the quota place was obtained, respecting the maximum quota per gender and per NOC.

In cases where, but not limited to, the event is cancelled or there are no eligible athletes, the unused quota place(s) will be reallocated to the next highest placed eligible athlete, not yet qualified, at the **D.1.3. Olympic Qualifier Series**, respecting the maximum quota per gender and per NOC.

The re-allocation will be implemented according to the timeline in section **G. Qualification Timeline**.



### **For D.1.2. Pathway**

Unused quota place(s) will be reallocated to the next highest placed eligible athlete from the relevant continent, not yet qualified, at the respective event where the quota place was obtained, respecting the maximum quota per gender and per NOC.

In cases where, but not limited to, the event is cancelled or there are no eligible athletes, the unused quota place will be reallocated to the next highest placed eligible athlete from the relevant continent, not yet qualified, at the **D.1.3. Olympic Qualifier Series**, respecting the maximum quota per gender and per NOC.

If there are no eligible athletes from the relevant continent at the **D.1.3. Olympic qualifier series**, the unused quota place will be reallocated to the next highest placed eligible athlete irrespective of continent, not yet qualified, at the **D.1.3. Olympic qualifier series**, respecting the maximum quota per gender per NOC.

The re-allocation will be implemented according to the timeline expressed in section **G. Qualification Timeline**.

## **F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES**

Unused host country places will be reallocated to the next highest placed eligible athlete, not yet qualified, at the **D.1.3. Olympic qualifier series**, respecting the maximum quota per gender and per NOC. The re-allocation will be implemented according to the timeline expressed in section **G. Qualification Timeline**.

## **F.3. REALLOCATION OF UNUSED UNIVERSALITY PLACES**
