Quota places allocated via the Olympic Qualifier Series are allocated to the athlete(s) by name. All other quota places, allocated via participation in UCI events described within this qualification system, are allocated to the NOC(s).

C. ATHLETE ELIGIBILITY

C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).





Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of the UCI, may participate in the Olympic Games Paris 2024.

C.2. Age requirements

To be eligible to participate in the Olympic Games Paris 2024, athletes must be born on or before 31 December 2009 (at least 15 years old or reaching this age in 2024).

C.3. Additional IF eligibility criteria

Athletes must also comply with the following criteria:

- Hold a valid cycling licence issued by a National Federation recognised by the UCI.
- Have participated in at least 1 of the following events: an Olympic Qualifier Series event, UCI World Championships or a UCI World Cup event within the qualification period (01 November 2022 to 23 June 2024).

For avoidance of doubt, athletes from other cycling disciplines are not eligible to participate in BMX Freestyle.

The qualification events are listed in hierarchical order of qualification:

D.2. QUOTA PLACES ALLOCATED BY NOC

All 6 (six) places available from the Olympic Qualifier Series shall be allocated, including any reallocation of such places should an individual athlete decline, prior to allocating the six (6) quota places by NOC (which includes the one (1) host country place allocated by NOC) which are attributed via the 2022 and 2023 UCI Urban Cycling World Championships.

D.3. HOST COUNTRY PLACES

The host country will automatically qualify one male and one female athlete for the Paris 2024 Olympic Games on the condition that the athletes meet the eligibility requirements described under section **C. Eligibility Criteria** of this document.

Should the host country obtain quota place(s) within section D., the host country place(s) will be reallocated as described in section **F. Reallocation of unused quota places** – method B.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

E.1. CONFIRMATION OF QUOTA PLACES

The UCI will publish the results of the events within 2 (two) days after the conclusion of the event on its website.

The UCI will confirm by e-mail to the NOCs on 26 June 2024, the quota places they have obtained. The NOCs will then have until 2 July 2024 to confirm to the UCI if they wish to use these quota places, as detailed in section **G. Qualification Timeline**.

E.2. CONFIRMATION OF HOST COUNTRY PLACES

The host country must confirm in writing to the UCI by 2 July 2024 the use of its host country places.

F. REALLOCATION OF UNUSED QUOTA PLACES

F.1. REALLOCATION OF UNUSED QUOTA PLACES

As a principle, since there are two separate and distinct methods by which quota is allocated (by name, via the Olympic Qualifier Series, and by NOC via the UCI events described in section D.), quota reallocation is likewise separated – quota by name is reallocated using the Olympic Qualifier Series final ranking, and quota by NOC is reallocated using the UCI qualification events.

Method A: Reallocation of quota places that were obtained by individual athletes participating in the Olympic Qualifier Series will be reallocated based on the Olympic Qualifier Series final ranking; to the next highest ranked eligible athlete in the OQSFR who has not obtained a quota place and represents an NOC that does not have two (2) athletes qualified. If such quota remains after the end of the OQSFR is reached, such quota shall be reallocated using Method B, after all quota allocation and reallocation to NOCs using UCI events is completed.





Method B: Quota places allocated to NOCs will be reallocated to the next highest ranked NOC at the 2023 UCI Cycling World Championships using the Elite Individual Results of the BMX Freestyle Park Contest, provided the NOC has not yet qualified a quota through the Olympic Qualifier Series or via the 2022 or 2023 UCI Urban Cycling World Championships.

F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused host country place(s) will be reallocated to the next highest-ranked NOC in the 2023 UCI Urban Cycling World Championships Elite Individual Ranking, not yet qualified for the Olympic Games, respecting the maximum quota per gender and per NOC.

C. ATHLETE ELIGIBILITY

C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of the UCI, may participate in the Olympic Games Paris 2024.

C.2. Age requirements

To be eligible to participate in the Olympic Games Paris 2024, athletes must be born on or before 31 December 2006 (at least 18-years old or reaching this age in 2024).

C.3. Additional IF eligibility criteria

Athletes must also comply with the following criteria:

- Hold a valid cycling licence issued by a UCI member national federation.
- Have at least 10 UCI ranking points in the UCI BMX Racing Individual ranking of 04 June 2024.

	For each men and women, the UCI BMX Racing Olympic Qualification ranking is calculated by summing the UCI points of the three (3) highest ranked athletes (without making distinction between Filte and Under 20) from each NOC taking into consideration each of

the athletes' results in the events listed below. The points are calculated for the period from 01 August 2022 to 02 June 2024 (the Qualification Period).

The UCI BMX Racing Olympic Ranking will be calculated as outlined <u>here</u> using the following events;

- UCI BMX Racing World Championships: results in 2023 and 2024;
- UCI BMX Racing World Cup events: best 14 results within the Qualification Period;
- Continental BMX Racing Championships: one (1) result in the Qualification Period; in case 2 or more Continental Championships events are held in this period in a continent, only the result closest in time to the end of the Qualification Period is used for that continent;
- International competition (HC): best three (3) results within the Qualification Period:
- International competition (C1): best seven (7) results within the Qualification Period;
- National BMX Racing Championships: one (1) result, CN in 2023.

Where an athlete has gained UCI points within the Qualification Period in both the Under 23 and the Elite categories, these points will be kept separate in the respective Under 23 and Elite rankings. Should an athlete appear twice within the top 3 athletes for their NOC by having points in both Under 23 and Elite, only the category with the higher points total will be taken into account for the calculation of the UCI BMX Racing Olympic Qualification ranking. In this situation, the next best ranked athlete from the NOC will be included in the UCI BMX Racing Olympic Qualification ranking calculation.

Tied NOCs will have their relative positions determined using the UCI BMX Racing Individual rankings of their athletes shown here on 04 June 2024 in the following order:

- The highest placed athlete in the UCI BMX Racing Elite Individual ranking,
- The highest placed athlete in the UCI BMX Racing Under 23 Individual ranking,
- The highest placed athlete in the UCI BMX Racing Junior Individual ranking.

Minimum Allocation per Continent (Europe and Oceania)

For Europe and Oceania, in case the continent does not have at least one (1) NOC represented, the last available quota place(s) through the UCI BMX Racing Olympic Qualification ranking will be allocated, with a maximum of one (1) quota place per NOC, to the highest ranked NOC of that continent. Any such allocation will result in a corresponding reduction (max. 1 per NOC) of places in the reverse order of the UCI BMX Racing Olympic Qualification ranking and provided that such reduction would not result in the continent of the NOC concerned losing its only quota.

D.2. HOST COUNTRY PLACES

The host country will be allocated one (1) quota place per gender on the condition that the athletes meet the eligibility requirements described under section C of this document.

Should the host country be allocated qualification place(s) via the qualification pathway outlined in section D, the host country place(s) will be reallocated as described in section **F. Reallocation of unused quota places**.





D.3. UNIVERSALITY PLACES

One (1) Universality place per gender is made available to eligible NOCs at the Olympic Games Paris 2024.

On 1 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality places is contained in the "Games of the XXXIII Olympiad, Paris 2024 - Olympic Games Universality Places - Allocation Procedure and Regulations" document.

The athletes offered the Universality quota places must have demonstrated their level during the qualification events and training camps, to be agreed with UCI if judged necessary in the lead up to the Olympic Games.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

E.1. CONFIRMATION OF QUOTA PLACES

The UCI will publish the UCI BMX Racing Olympic Qualification Ranking on 04 June 2024 on the UCI website.

The UCI will confirm in writing via email to the NOCs within seven (7) days after the ranking publication date, the quota places they have been allocated. The NOCs will then have fourteen (14) days to confirm in writing via email to the UCI at offroad@uci.ch if they wish to use these quota places, as detailed in section H. Qualification Timeline.

E.2. CONFIRMATION OF HOST COUNTRY QUOTA PLACES

The host country must confirm in writing via email to the UCI at offroad@uci.ch by 25 June 2024 the use of its host country quota places.

F. REALLOCATION OF UNUSED QUOTA PLACES

F.1. REALLOCATION OF UNUSED QUOTA PLACES

F.1.1. If a quota place allocated through the UCI BMX Racing Olympic Qualification ranking is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, the quota place will be reallocated to the next highest ranked NOC in the UCI BMX Racing Olympic Qualification ranking, which has not yet obtained a quota place.





- F.1.2. If a quota place allocated through the elite individual results from the 2023 BMX Racing Continental Championships is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, the quota place will be reallocated to the next highest ranked NOC from the respective continent in the elite individual results of the 2023 BMX Racing Continental Championships, which has not yet obtained a quota place. If no NOC is eligible, the quota place will then be allocated to the next highest ranked NOC from the same continent on the UCI BMX Racing Olympic Qualification ranking, which has not yet obtained a quota place.
- F.1.3. If a quota place allocated through the elite individual results from the 2023 UCI BMX Racing World Championships is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, the quota place will be reallocated to the next highest ranked NOC in the respective elite individual results of the 2023 UCI BMX Racing World Championships, which has not yet obtained a quota place. If no NOC is eligible, the quota place will then be allocated to the next highest ranked NOC on the UCI BMX Racing Olympic Qualification ranking, which has not yet obtained a quota place.
- F.1.4. If a quota place allocated through the elite individual results from the 2024 UCI BMX Racing World Championships is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, the quota place will be reallocated to the next highest ranked NOC in the respective elite individual results of the 2024 UCI BMX Racing World Championships, which has not yet obtained a quota place. If no NOC is eligible, the quota place will then be allocated to the next highest ranked NOC on the UCI BMX Racing Olympic Qualification ranking, which has not yet obtained a quota place.
- F.1.5. If a quota place allocated through Universality places is not confirmed by the NOC by the confirmation of quota place deadline set by the IOC Tripartite Commission, the Universality place will be reallocated to the next highest ranked NOC on the UCI BMX Racing Olympic Qualification ranking, which has not yet obtained a quota place.

F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

F.2.1. Unused host country place(s) will be reallocated to the next highest ranked NOC in the UCI BMX Racing Olympic Qualification Ranking, not yet qualified for the Olympic Games, respecting the maximum quota per gender and per NOC.

G. RESERVE AND AP ATHLETES

G.1. RESERVE ATHLETES

G.1.1 Reserve athletes are competing athletes who have an Aa accreditation and who are entered by their NOC in a specific event for which the NOC has a quota place, and the athlete has met the required eligibility criteria. As reserves, they may be selected to replace another entered athlete in a different cycling discipline/event until the time of the final confirmation for that event,





provided that they have met the required eligibility criteria and the NOC quota for that event is respected.

G.2. AP ATHLETES

- G.2.1 Ap athletes are non-competing athletes accredited in the "Ap" category who have different entitlements to competing athletes (accredited as "Aa") as described in the "Ap" accreditation quotas and conditions outlined in the IOC Accreditation Guide. These personnel are not part of the athlete quota as described in section **B. Athlete Quota**. "Ap" alternate athletes could become competing athletes only under the conditions outlined in the IOC/Paris 2024 Late Athlete Replacement policy.
- G.2.2. "Ap" athletes must comply with the same eligibility rules as competing athletes as described in paragraph **C. Athlete Eligibility**.
- G.2.3. Each qualified NOC is entitled to one (1) "Ap" athlete per gender.

- Hold a valid UCI license issued by a UCI member national federation
- Have at least 10 UCI points in the UCI Cross-country individual ranking of 28 of May 2024.

The UCI Mountain Bike Olympic Qualification Ranking is calculated by summing the points of the three (3) highest placed athletes from each NOC in a ranking which includes all events which are taken into account in the UCI Cross-country Individual ranking, over each of the aforementioned periods.

A maximum of two (2) Continental Championships are included in the UCI Mountain Bike Olympic Qualification ranking. If more than two (2) Continental Championships take place during the qualification period, the two (2) latest are included.

Tied NOCs have their relative positions determined by their highest placed athlete on the ranking which includes all events which are taken into account in the UCI Cross-country Individual ranking, over the qualification period.

Minimum Allocation per Continent (Europe and Oceania)

For Europe and Oceania, in case the continent does not have at least one (1) NOC represented, the last available quota place(s) through the UCI Mountain Bike Olympic Qualification ranking will be allocated, with a maximum of one (1) quota place per NOC, to the highest ranked NOC of that continent. Any such allocation will result in a corresponding reduction (max. 1 per NOC) of places in the reverse order of the UCI Mountain Bike Olympic Qualification ranking and provided that such reduction would not result in the continent of the NOC concerned losing its only quota.

D.2. HOST COUNTRY PLACES

The host country will be allocated one (1) quota place per gender on the condition that the athletes meet the eligibility requirements described under section C of this document.

Should the host country gain qualification place(s) within section D.1., the host country place(s) will be reallocated as described in section **F. Reallocation of unused quota places**.

D.3. UNIVERSALITY PLACES

One (1) Universality place per gender is made available to eligible NOCs at the Olympic Games Paris 2024.

On 2 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality places is contained in the "Games of the XXXIII Olympiad, Paris 2024 - Olympic Games Universality Places - Allocation Procedure and Regulations" document.

The athletes offered the Universality quota places must have demonstrated their level during the qualification events and training camps to be agreed with UCI if judged necessary in the lead up to the Olympic Games.





E. CONFIRMATION PROCESS FOR QUOTA PLACES

E.1. CONFIRMATION OF QUOTA PLACES

The UCI will publish the UCI Mountain Bike Olympic Qualification Ranking on 28 May 2024 on its website.

The UCI will confirm in writing via email to the NOCs on 3 June 2024, the quota places they have obtained. The NOCs will then have until 17 June 2024 to confirm in writing via email to the UCI at offroad@uci.ch if they wish to use these quota places, as detailed in section **H. Qualification Timeline**.

E.2. CONFIRMATION OF HOST COUNTRY PLACES

The host country must confirm in writing via email to the UCI at offroad@uci.ch by 17 June 2024 the use of its host country places.

F. REALLOCATION OF UNUSED QUOTA PLACES

F.1. REALLOCATION OF UNUSED QUOTA PLACES

- F.1.1. If a quota place allocated through the UCI Mountain Bike Olympic Qualification ranking is not confirmed by the NOC by the confirmation of quota place deadline, or is declined by the NOC, the quota place will be reallocated to the next highest ranked eligible NOC in the UCI Mountain Bike Olympic Qualification ranking, which has not yet obtained a quota place.
- F.1.2. If a quota place allocated through the Elite Individual results from the 2023 Continental Championships is not confirmed by the NOC, or is declined by the NOC, the quota place will be reallocated to the next highest ranked NOC from the respective continent in the Elite Individual results of the 2023 Continental Championships, which has not yet obtained a quota place. If no NOC is eligible, the quota place will then be allocated to the next highest ranked eligible NOC from same continent on the UCI Mountain Bike Olympic Qualification ranking, which has not yet obtained a quota place.
- F.1.3. If a quota place allocated through the Elite or U23 Individual results from the 2023 UCI World Championships is not confirmed by the NOC, or is declined by the NOC, the quota place will be reallocated to the next highest ranked eligible NOC in the respective Elite or U23 Individual results of the 2023 UCI World Championships, which has not yet obtained a quota place. If no NOC is eligible, the quota place will then be allocated to the next highest ranked eligible NOC on the UCI Mountain Bike Olympic Qualification ranking, which has not yet obtained a quota place





F.1.4. If a quota place allocated through Universality places is not confirmed by the NOC by the confirmation of quota place deadline set by the IOC Tripartite Commission, the Universality place will be reallocated to the next highest ranked NOC on the UCI Mountain Bike Olympic Qualification ranking, which has not yet obtained a quota place.

F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

F.2.1 Should the host country qualify qualification places or decide not to use the allocated host country places, the latter will be reallocated to the next highest ranked eligible NOC in the UCI Mountain Bike Olympic Qualification ranking, which has not yet obtained a quota place.

G. RESERVE ATHLETES

G.1. Reserve athletes are competing athletes who have an Aa accreditation and who are entered by their NOC in a specific event for which the NOC has a quota place and the athlete has met the required eligibility criteria. As reserves, they may be selected to replace another entered athlete in a different cycling discipline/event until the time of the final confirmation for that event, provided that they have met the required eligibility criteria and the NOC quota for that event is respected.

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of the UCI, may participate in the Olympic Games Paris 2024.

C.2. Age requirements

All athletes participating in Road Cycling at the Olympic Games Paris 2024 must be born on or before 31 December 2005 (at least 19 years old or reaching this age in 2024).

C.3. Additional IF eligibility criteria

To be eligible to participate in the Olympic Games Paris 2024, all athletes must:

- Hold a valid UCI license issued by a UCI member national federation.
- Have at least 10 UCI points in the Individual UCI Road World Ranking of 17 October 2023 or 25

Minimum allocation per continent

If a quota place allocated for the Road Race is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated as follows:

- Having gained at least 10 UCI points in an event counting towards the UCI Track Olympic Ranking

D. QUALIFICATION PATHWAY

D.1. QUOTA PLACES

The UCI Track Olympic Ranking 2022-2024 is used to allocate the 190 athletes quota places.

A specific UCI Track Olympic Ranking by nations 2022-2024 is established for each of the events of Track Cycling, as defined hereafter. Reference to the UCI Track Olympic Ranking 2022-2024 under section Qualification Events below shall refer to the event specific ranking by nations.





Events:

Each UCI Track Olympic Ranking 2022-2024 includes the points acquired in the following events during the period defined as Qualification Timeline in section H.:

- The last two editions of the respective Continental Championships;
- Best two results in UCI Track Nations Cup in each of the seasons 2023 and 2024; and
- The 2023 UCI (Elite) Track World Championships.

Points scales:

Each UCI Track Olympic Ranking 2022-2024 shall apply the points scales detailed in article 3.3.010 adapted as follow:

- Continental Championships points multiplied by 0.75
- Nations Cup points as is
- World Championships points multiplied by 1.5

Number of Riders/Teams considered:

Individual events – only the best rider of each nation in each event will score points for the corresponding ranking.

Team events – only the best team of each nation in each event will score points for the corresponding ranking.

Points allocation:

For each event, points shall be allocated according to the applicable points scale considering only one rider, respectively team, for each nation. The ranking of any further rider, respectively team, shall be disregarded (for example, if riders or teams from the same NOC rank first and second, the NOC ranked third shall be allocated the points for rank two).

In addition, the fifteen (15) NOCs qualified in the Madison are given the right to enter one (1) athlete in Omnium*, subject to all of the following conditions being met: • The selected athlete must already be qualified for and entered in another Track event or another Cycling discipline, and; • All quotas per NOC and per event must be respected. The total number of athletes taking part in Omnium could therefore reach a maximum of 22.

*Whenever qualification through the UCI Track Olympic Ranking of a first event gives right to the NOC to enter an athlete or team in a second event (Team Sprint to Sprint and Keirin; Team Pursuit to Madison; Team Pursuit or Madison to Omnium), the NOC concerned must confirm participation in the first event in order to benefit of such automatic right of entry in the second (or third) event. If the NOC does not confirm entry in the first event, it may still qualify quota places for the second (or third) event via the other applicable criterion (i.e. the UCI Track Olympic Ranking 2022-2024 for the second (or third) event).

Special Provisions

- 1. In each gender, if a continent is not represented in any sprint type event (Team Sprint, Sprint or Keirin), the highest ranked NOC on the UCI Track Olympic Ranking 2022-2024 for Sprint of that continent, shall be entitled to one (1) quota place in the Sprint event. Any such allocation will result in a corresponding reduction (max. 1 per NOC) of places allocated to NOCs through the UCI Track Olympic Ranking 2022-2024 for Sprint, in the reverse order of the latter.
- 2. In each gender, if a continent is not represented in any endurance type event (Team Pursuit, Madison or Omnium), the highest ranked NOC on the UCI Track Olympic Ranking 2022-2024 for Omnium of that continent shall be entitled to one (1) quota place in the Omnium event. Any such allocation will result in a corresponding reduction of places allocated to NOCs through the UCI Track Olympic Ranking 2022-2024 for Omnium, in the reverse order of the latter.





D.3. HOST COUNTRY PLACES

No host country quota places are available in Track for the Olympic Games Paris 2024.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

E.1. CONFIRMATION OF QUOTA PLACES

Following each qualification event, the UCI will publish the results on its <u>website</u> and update the corresponding UCI Olympic Track Ranking. On 15 April 2024, the final UCI Track Olympic Ranking of each event will be published on the UCI website and by 22 April 2024, the UCI will inform by email (<u>track-para@uci.ch</u>) the respective NOCs of their allocated quota places.

The NOCs will then two weeks to confirm to the UCI by email (track-para@uci.ch) if they wish to use these quota places, as detailed in section **H. Qualification Timeline**.

F. REALLOCATION OF UNUSED QUOTA PLACES

F.1. REALLOCATION OF UNUSED QUOTA PLACES

If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline (6 May 2024), or is declined by the NOC, the quota place will be reallocated, in the same event, to the next highest-ranked eligible NOC on the respective UCI Track Olympic Ranking 2022-2024 (from the same continent if continental representation is affected), which has not yet qualified for the respective event and respecting the maximum quota per gender and per NOC and special provisions 1 and 2.

In case no NOC is eligible for reallocation according to the above process, the quota place will be reallocated, in the same event, to the next highest ranked NOC on the final UCI Track Olympic Ranking 2022-2024 (from the same continent if continental representation is affected), which has not yet qualified for the respective event and respecting the maximum quota per gender and per NOC and special provisions 1 and 2.

G. RESERVE AND AP ATHLETES

G.1. RESERVE ATHLETES

Reserve athletes are competing athletes who have an Aa accreditation and who are entered by their NOC in a specific event for which the NOC has a quota place and the athlete has met the required eligibility criteria outlined in section C. As reserve athletes, they may be selected to replace another entered athlete





in a different cycling discipline/event until the time of the final confirmation for that event, provided that they have met the required eligibility criteria and the NOC quota for that event is respected.

G.2. AP ATHLETES

Ap athletes are non-competing athletes accredited in the "Ap" category who have different entitlements to competing athletes (accredited as "Aa") as described in the "Ap" accreditation quotas and conditions outlined in the IOC Accreditation Guide. These participants are not part of the athlete quota as described in section **B. Quota Places.** "Ap" alternate athletes could become competing athletes only under the conditions outlined in the IOC/Paris 2024 Late Athlete Replacement policy.

Eligibility:

"Ap" athletes must comply with the same eligibility rules as competing athletes as described in section **C. Athlete Eligibility**.

Quota:

Each qualified team in Team Sprint is entitled to one (1) Ap athlete.

Each NOC with a team qualified in Team Pursuit or Madison is entitled to one (1) Ap athlete.
