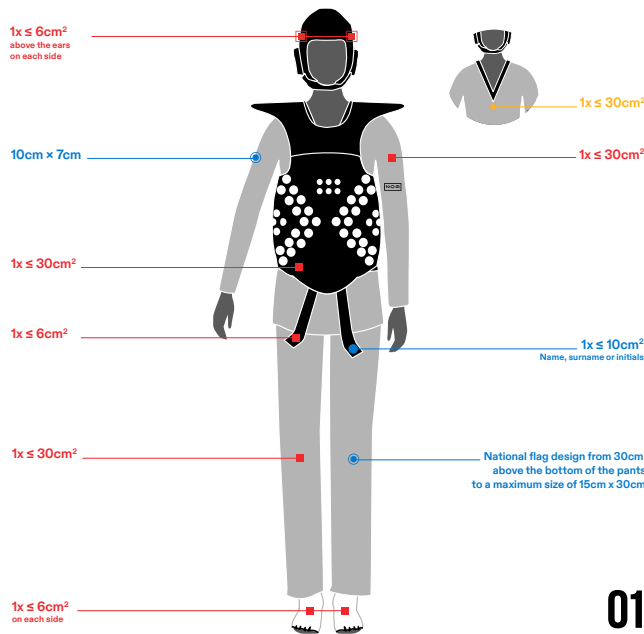
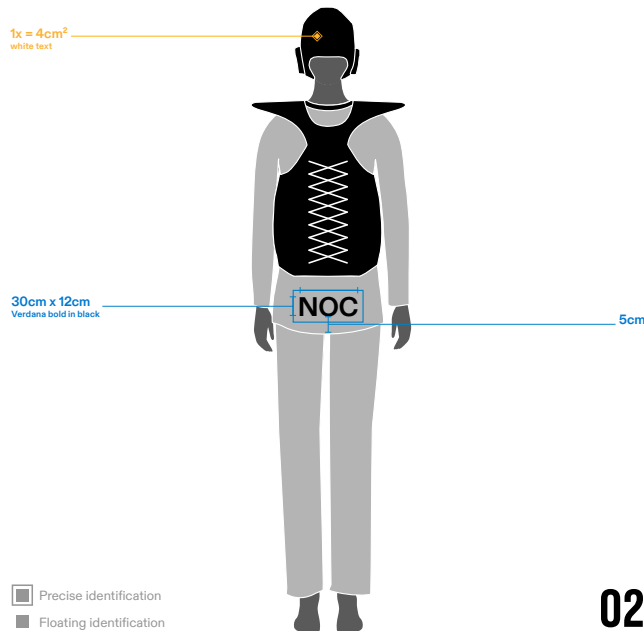

Precise identification  
 Floating identification

All General Principles apply unless expressly mentioned otherwise hereafter (in particular in relation to size, frequency or location). Please refer to the “Identifications on NOC Team Apparel Practical Guidelines”, and General Guidelines (released Summer 2023) to obtain the general principles of Authorised Identifications on NOC uniforms at the Olympic Games. This section provides visual illustrations regarding the placement and size of Sport Specific Implementation for any items.

## SUBMISSION PROCESS

No additional obligatory submission process required by the IF, section 14 of the General Guidelines applies.

### 01 ATHLETE FRONT

#### Identification of the Manufacturer

##### Clothing

- Trousers | Jacket**  
 One *Identification of the Manufacturer* [■] per clothing item will be permitted, to a maximum size of 30cm<sup>2</sup> (3 to 3.5cm below the shoulder line of the left arm.)
- Tracksuit**  
 One *Identification of the Manufacturer* per clothing item will be permitted, to a maximum size of 30cm<sup>2</sup>.
- Belt**  
 One *Identification of the Manufacturer* [■] per item will be permitted, to a maximum size of 6cm<sup>2</sup>.

##### Sport Equipment

- Trunk Protector | Scoring System (PSS)**  
 One *Identification of the Manufacturer* [■] will be permitted, to a maximum size of 30cm<sup>2</sup>.
- Shin guard | Arm guard | Other protective equipment**  
 One *Identification of the Manufacturer* per item will be permitted, not greater than 10% of the surface area of the item, to a maximum size of 14cm<sup>2</sup>.
- Sensing socks**  
 One *Identification of the Manufacturer* [■] per item will be permitted, to a maximum size of 6cm<sup>2</sup>.
- Head Protector | Scoring System (PSS)**  
 Two *Identifications of the Manufacturer* [■] per item will be permitted, to a maximum size of 6cm<sup>2</sup> of each and placed above either one of the ears.

*Note: Trunk Protector, Sensing socks, Head protection and Gloves are provided by the Organising Committee.*

##### Accessories

- Bag**  
 One *Identification of the Manufacturer* per item will be permitted, not greater than 10% of the surface area of the item, to a maximum size of 60cm<sup>2</sup>.

##### Shoes/Footwear

- Shoes**  
 All footwear items may carry the *Identification of the Manufacturer* as generally used on products sold through the retail trade during the period of 6 months or more prior to the Games.

#### Product Technology Identification

##### Clothing

**Tracksuit**  
 One additional *Product Technology Identification* will be permitted per clothing item with a maximum size of 10cm<sup>2</sup>.

#### NOC Emblem and National Identity

Additional IF Specifications

##### Section 05

##### Third Party Identifications (athlete names)

The athlete's full name(s) or family name(s) or initial of the first name and family name(s), may appear on the belt once, to a maximum size of 10cm<sup>2</sup>.

No names of athletes are allowed on any other items, section 05 of the General Guidelines applies.

##### Section 07

##### NOC Emblems and National Identity

##### National flag/NOC emblem

On competition clothing, the national flag or NOC emblem [●] must be located on the right arm, with a size of 10cm × 7cm (3 to 3.5cm below the shoulder line of the right arm).

#### Homologation Marks

Additional IF Specifications

##### Clothing

- Jacket**  
 One IF *Homologation Mark* [◆] will be permitted in front of the jacket where the black neck bands are met with a maximum size of 30cm<sup>2</sup>.

##### Sport Equipment

- Shin guard | Arm guard | Other protective equipment**  
 One IF *Homologation Mark* will be permitted with a maximum size of 10cm<sup>2</sup>.

##### NOC Emblems and National Identity

##### NOC code

On competition clothing, the NOC code must be printed in black on the upper garment, using bold Verdana font, and located 5cm or higher from the lower edge of the jacket within the size of 30cm x 12cm.

#### Homologation Marks

##### Section 09

##### Homologation Marks

Homologation marks (CE) [◆] must be located on the left side of the centre of the back of head of the PSS, in a white text colour and within a size of 4cm<sup>2</sup>.
